Advantages & Challenges of Christian Counselor

- Advantages:

 - Lord's example to follow (John 12:26)
 - Lord providing His leading in each situation now (John 14:16, 26)
- Challenges/Responsibilities:
 - Expectations of client/patient
 - Accountability before Lord (Rom 14:12)

Defining Characteristics of His Ministry (p 1)

1. Motivated by love (John 15)
2. Desire for restoration (Luke 19:10)
3. Personal, face to face (John 11)
4. Relationship not based on guilt/coercion
5. Relationship over time (Matt 4:18, John 21)
6. Attention to all needs (B,P,S,S)

Defining Characteristics of His Ministry (p 2)

7. Focus on needs of other, not self
8. Variety interventions, no formula
9. Attention to unseen (heart, future)
10. Doing the “best” thing (Luke 10:41-42)
11. Submitted/accountable (John 8:29)
12. Doing the will One who sent Him (John 6:38); what He saw Him do (John 8:38)

Systematic Study of the Gospels: Preliminary Analysis (p 1)

- *A Harmony of the Gospels, NASB.* (R.L. Thomas and S.N. Gundry, 1978)
 - Four gospels, arranged chronologically, in parallel
 - Divided into 259 sections
- Study of Jesus' ministry (200 sections), coding His actions in each: type of activity, recipient, setting, etc. (multiple coding)

WHJEMTD?: Skills

- Interview, and listen
- Develop therapeutic relationship
- Assess problems, and discern root causes
- Develop treatment plan
- Follow treatment/counseling process
- Make specific interventions in context of counseling relationship and process

- Instruct
- Build up, encourage
- Correct
- Warn, admonish
- Bring healing

WWJHMDN?: Hearing from the Lord

- Depends on our relationship with the Lord and our devotional life
- Attitude of openness & expectancy
- Hearing from God in the situation vs.:
 - Teachings of particular school of therapy
 - Formulas of favorite self-help book
 - Natural preferences
- Sensitivity to critical moments in therapy

- Daniel
 - Man of wisdom
 - Heard from God
 - Provided counsel
 - Lived and ministered in enemy territory
- Characteristics of his ministry (Dan 2:14):
 - Discernment

APA Ethics Statement

- I. Respect patient's religious beliefs
 - A. Obtain info about beliefs
 - B. Respect pt. vulnerabilities and beliefs
 - C. Feedback in context of pt. beliefs
- II. Should not impose own beliefs or substitute them for sound clinical practice
 - A. Not force (anti)religious agenda
 - B. Religious concepts or rituals not offered as substitutes for clinical practice

WWJHMDN?:

Principle of the Second Thing

- First, natural body; second, spiritual body. First man, from the earth; second man, from heaven. Natural comes first, then the spiritual comes second (I Cor. 15:42-47)
- Examples of superiority of second thing: second sight, second veil, second coming
- Our first thought is from natural mind, second thought is from the Holy Spirit

WWJHMDN?:

Holy Spirit Present in Situation

- Ministry of the Holy Spirit
 - Present with us (John 14:16)
 - Brings conviction (John 16:8)
 - Guides us into all truth (John 16:13)
 - Brings to remembrance (John 14:26)
 - Reveals to us (I Cor 2:10; Eph 3:5)
 - Intercedes for us (Rom 8:26)
